Admissions

Admission requirements

- An undergraduate degree from a recognized university with at least a B average (3.0 GPA) or equivalent. We consider 3-year degrees on a case-by-case basis.
- Two years of work experience preferred. Three years for those with a 3-year undergraduate degree.
- If your first language is not English, you must submit an official TOEFL iBT® or IELTS. Tests cannot be more than two years old. We require an overall IELTS score of 7.0 with no band below 6.5.
- You must provide a current CV and supplementary documents including references and you must be available for a timed online interview.

Scholarship details

Upon applying to the Sobey MBA program you are automatically considered for an entrance scholarship up to \$10,000. Canadian citizens and permanent residents will also be considered for one of four \$35,000 Sobey MBA Scholarships.

Studying in Canada

As an international student you are required to obtain a study permit issued by Immigration, Refugees and Citizenship Canada before you arrive in Canada. You may apply once you receive your official letter of acceptance from Saint Mary's University by email. Apply early for your permit as processing times can vary.

International students are permitted to work part-time (on or off campus) while studying in a full-time degree program. Additionally, international students may qualify for up to a three-year post-graduate work permit in Canada as part of the Canada Experience Class. The Saint Mary's University International Student Centre can assist you with the work permit process.

International learning experience

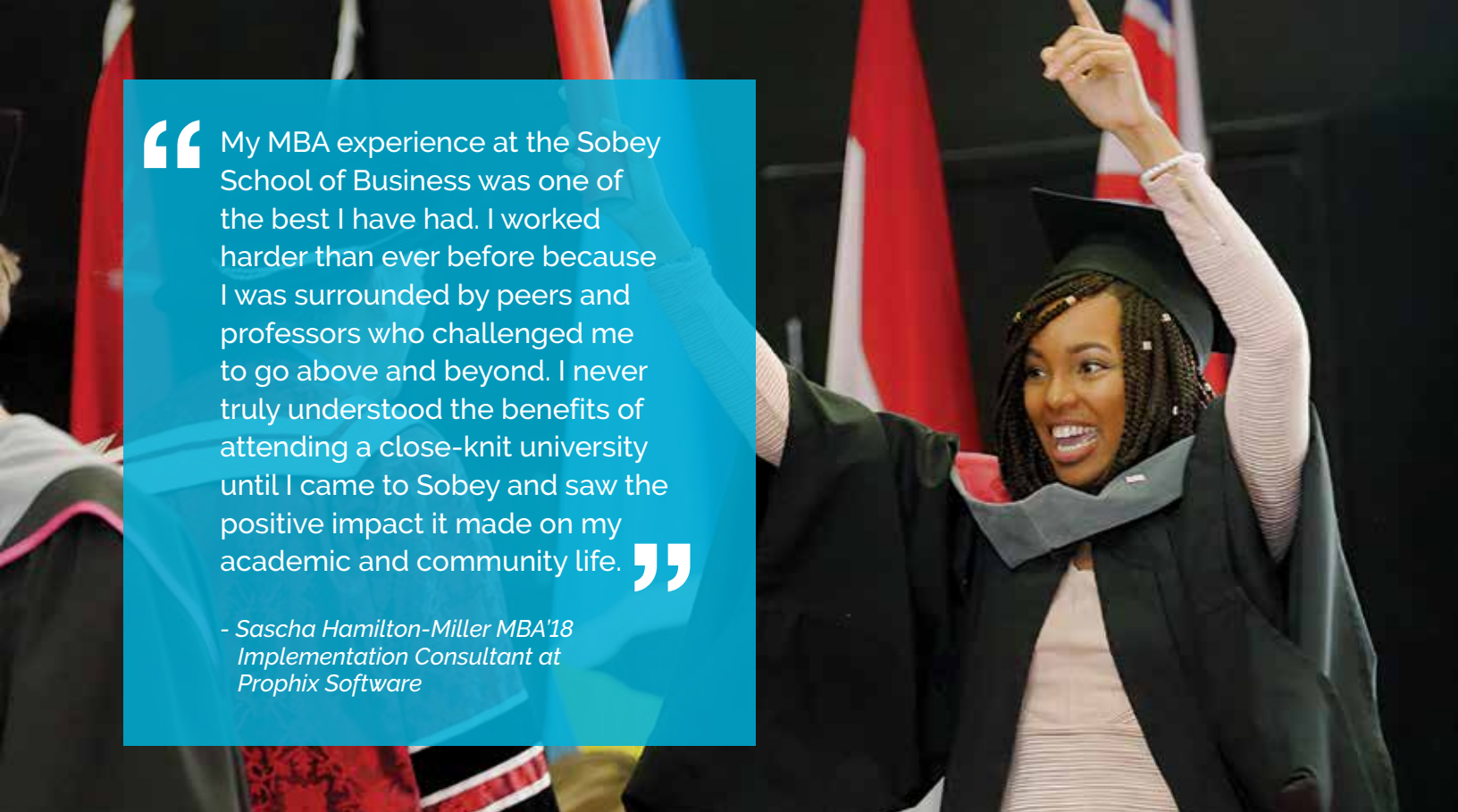

Focus and integrate

After mastering the fundamentals in your first year, in the last semester, you'll apply what you've learned and focus in a specialized area. You may choose electives from a wide range of areas: management consulting, finance and entrepreneurship are just a few. You'll choose electives that will deepen your understanding of your area of focus. Taught by world-class faculty, the program is cohort-based and is completed in 16 months (full-time). It is recognized as a two-year program.
